### **Educational Programs:**

### **Community Service:**

Organising blood donation camps and other health-related activities.

### **Environmental Initiatives:**

Tree plantation drives, composting projects, and campaigns to reduce the use of single-use plastics.

### **Art and Culture:**

Street painting events to raise awareness on social and environmental issues.

### **Roles & Responsibilities-**

Hamara Pyar Hisar Welfare Society: Provide expertise and resources for the planned activities. Coordinate with external partners and stakeholders. Monitor and evaluate the progress of the initiatives.

GGJ Government College, Hisar:

-Facilitate the participation of students and staff in the activities.

-Provide necessary infrastructure and logistical support.

-Promote the initiatives within the college community.



### **Duration-**

This MOU shall be effective from the date of signing and shall remain in force for a period of two years. It may be extended by mutual written consent of both parties.

### **Amendments-**

Any amendments to this MOU shall be made in writing and signed by authorised representatives /office bearers of both parties.





