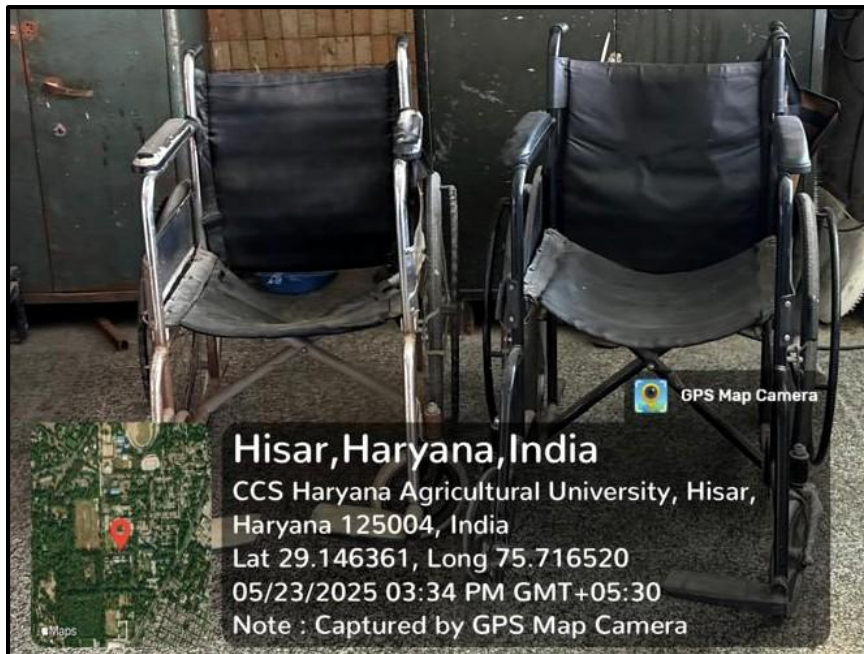

The Handicap Committee, of G.G.J Govt. College, Hisar has ensured to provide all the facilities, information and privileges accessible to students with disabilities. The Committee has followed then guidelines smoothly for conducting Theory and Practical Examination for Regular and Distance Education course as well as entrance test for disabled students by giving them rooms at ground floor in an accessible building equipped with disabled friendly toilets and providing writers to write on the behalf of them. The Extra Time is Allowed for the Government Guideline E.D 5 UNE 204/ Dated 5.3.2004 and E.D UNE 2004, Dated 22.3.2004, The following guideline are to be strictly followed

- The Blind student can select the scribe.
- The scribe need not have a qualification lower then that of the students.
- A physically disabled/blind/hearing impaired candidate and the scribe for such a candidate shall be allowed an extra time of 20 minutes per hour. Where the facility of writer is provided to any candidate, he/she may be assigned a separate invigilator and a separate room. This provision must be also be made for candidates who do not require a writer but are permitted compensatory time.



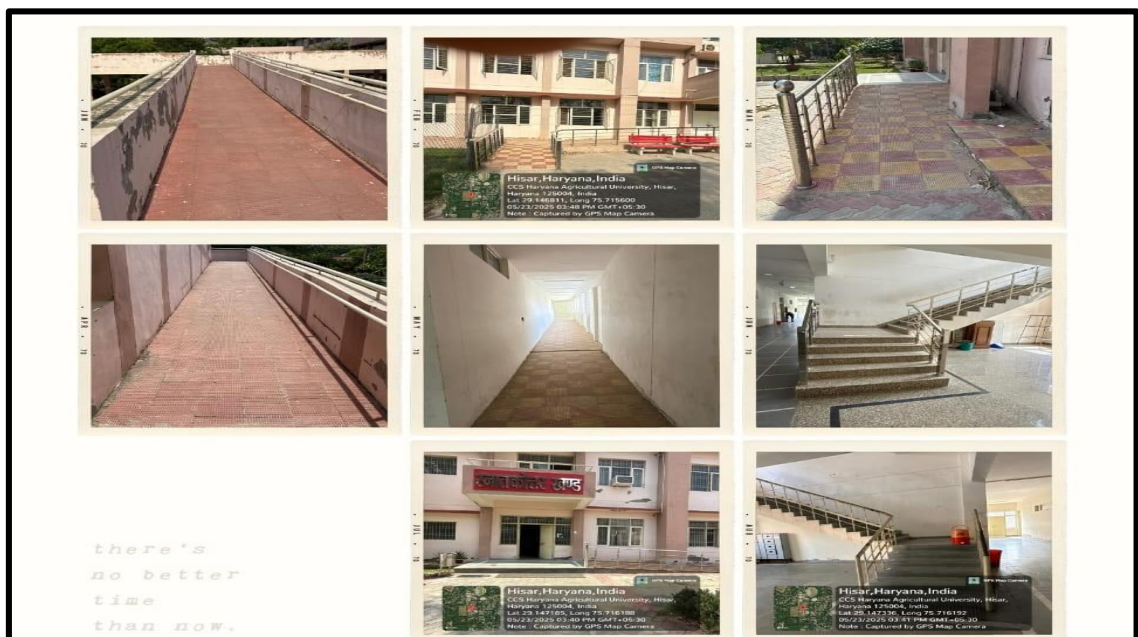
The committee helped 18 students in getting NSP & other meritorious scholarship during session 2024-25. The Committee made proper arrangements for drinking water for disabled students. The Committee has also held a meeting for the disable students to hear and solve their grievances time to time. The Handicap Committee has provided two wheel chairs along with a peon (partially blind, a disable person) who work as an assistant to move these wheel-chairs for the disable students on the ramps, newly built with the instructions following guidelines set by the New Act.



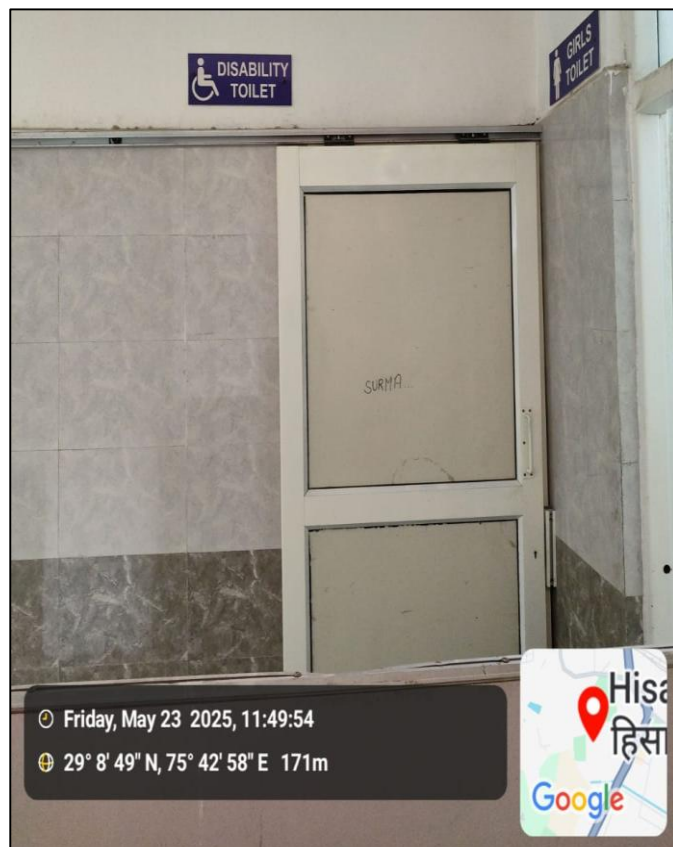
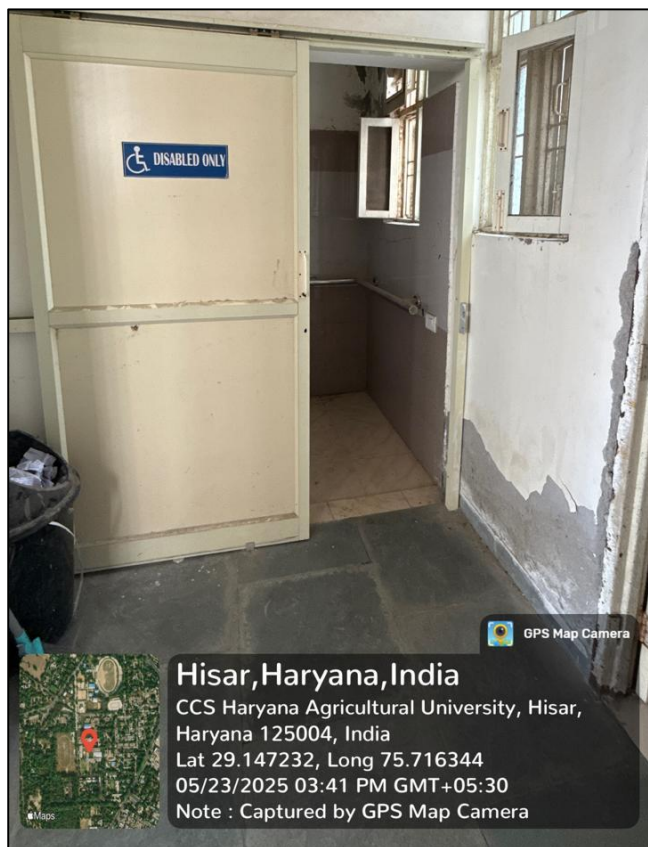
Special facilities provided by the college.

The college provides some special facilities for the differently abled students to provided them quality education and to bring them into mainstream of the society. The facilities listed below :

- **Reservation in admission** : The college provided reservation for the differently abled students as the university guideline.
- **Ramps and Railing** : the college has a special facility of ramp and rails for the differently abled students. Near the main entrance of the college building the ramp is clearly identifiable and easily accessible. Floor steps and ramps have hand railing for support.



- **Special Toilet and Class Room** : Toilet and Class room are available at the ground Flor to facilitate the visits of differently abled students.



- **Reading Room** : Reserved seats facility is made available to differently abled students at library as well in reading room. It is easily accessible to the above students. They are given permission to access the books as per their requirements.
